Comments; The entrance to the 'Car Port' is close to the roadway and could cause problems of visibility for emerging vehicles. The size is somewhat large compared with the main property.

Comments; The 'Gable End' style of the extension is out of keeping in both appearance and size with the adjacent properties

#### 7. Report; Sphere Taxi Project;

Cllr C Williams reported that the use of the taxi facility was very variable with no definite pattern evident. At the present level of use it would be hard to justify continuing beyond the funding end in March 2009. The Management Committee would be meeting soon to review the operation.

#### 8. The informal group on Housing and Planning;

Cllr R Jackson reported on the discussions that had been held with Malvern Hills District Council Head of Planning Mr D Rudge. The concept of the Parish Plan becoming a binding Supplementary Planning Document (SPD) turned out to be a rather more daunting task than previously envisioned although the draft proposals were well received by Mr Rudge as a likely basis for a consultative document.
